Senator lauds efforts to ease rice, pork prices, urges tighter checks

MANILA — Senator Sherwin Gatchalian on Thursday lauded efforts of the Marcos administration to ease the prices of rice and pork, as he emphasized the need for these decreases to benefit consumers directly.

“The expected reduction in rice and pork prices is welcome news for consumers, offering much-needed relief after months of elevated commodity

prices,” Gatchalian said in a statement.

On Wednesday, the Department of Agriculture (DA) said rice prices have been dropping since December 2024.

This is attributed to the sharp tariff reduction on rice imports ordered by President Ferdinand R. Marcos Jr., various DA programs such as the Rice for All under the Kadiwa ng Pangulo, and the declaration of

a food security emergency that allowed the National Food Authority (NFA) to release its rice stocks to local government units.

Meanwhile, the retail prices of pork may start to drop in the middle of March due to a decline in farmgate prices, the cooperation of pork industry traders and retailers, and the expected implementation of a maximum suggested retail price

102 senior citizens in Imus receive cash gifts



CITY OF IMUS, Cavite (PIA) — A total of 102 senior citizens in the City of Imus, Cavite, received cash gifts from the National Commission of Senior Citizens (NCSC) under the Expanded Centenarians Act of 2024 on Wednesday, Feb. 26.

The cash gift distribution was part of a nationwide simultaneous event, with the main ceremony held at Malacañang Palace.

At least 51 senior citizens aged 80; 33 aged 85; 12 aged 90; and five aged 95 each received P10,000. Meanwhile, the lone

centenarian, Nanay Apolinaria Sapino, who passed away three days after her birthday, was represented by her daughter, Marissa Sapino Alejo, who

received the P100,000 cash gift from the NCSC.

The NCSC emphasized that this initiative is a small but heartfelt recognition of the gov-

ernment for the sacrifices and valuable contributions of senior citizens to the community, ensuring they receive sufficient support and care,” the NCSC said in a statement.

The Imus City Government expressed gratitude to the national government and NCSC officials

for choosing the City of Imus as one of the first recipients of the Expanded Centenarians Act of 2024. They noted that all required documents were submitted in an organized manner, complying with NCSC requirements.

Senior citizens and their families also extended their gratitude to the government for the financial gift.

(MSRP) for pork by March 10.

However, Gatchalian said the government must ensure that the price reductions are fully reflected at the retail level, "to allow Filipino families to allocate more of their hard-earned income to other basic necessities."

He urged the DA and the Department of Trade and Industry to intensify price monitoring efforts and crackdown on unfair market practices, in-

cluding hoarding and price manipulation, to prevent consumers from being burdened by artificially inflated prices.

"I also call on retailers and suppliers to do their part in keeping food prices reasonable," he said.

Gatchalian also stressed the importance of strengthening support to farmers and livestock raisers to boost production and reduce costs to ensure the sustainability of lower prices. (PNA)

Gov't focusing efforts on early childhood dev't, education – Palace

MANILA – The government is prioritizing efforts to improve early childhood development as part of the thrust to uplift the country's overall educational standards.

She further reassured the public that the administration is committed to addressing educational issues.

"Hindi po nabahala ang ating Pangulo dahil sa atin po, sa panahon po ngayon, lahat po ng paraan ay ginagawa po natin para maiangat po ang lebel ng ating edukasyon (We are not really alarmed because right now, we're doing every means possible to improve the quality of education)," Castro said.

One of the government's initiatives, according to Castro, is aimed at improving foundational education for young children as recommended by the Second Congressional Commission on Education (EDCOM 2).

President Ferdinand R. Marcos Jr. recently approved the allocation of some PHP700

especially with the upcoming 2025 national and local elections.

DSWD Calabarzon Regional Information Officer Joseph Arceo said that they will strictly adhere to the Commission on Elections (Comelec) guidelines, which prohibit candidates from being present at payout areas during cash aid distribution.

Apolinaria, shared that while it is saddening that her mother could not personally receive the recognition and assistance, their family remains grateful. She also hopes that more support will continue to be provided to the elderly.

Nanay Apolinaria celebrated her 100th birthday on January 5, 2025, but passed away three days later.

Mayor Alex Advincula commended senior citizens for their contributions in shaping the city into one that is more responsive to the needs and well-being of its residents.

In addition to receiving cash gifts, the beneficiaries availed themselves of free medical

"With the help of Land Bank of the Philippines, we have digital partners handling the disbursement of payouts, ensuring that assistance reaches our clients safely, quickly, and conveniently," Arceo said.

In a memorandum issued last month, the Comelec granted

DSWD Secretary Rex Gatchalian's request to exempt the AKAP and other social welfare programs from the 45-day spending ban for the May 2025 elections.

One of the three conditions that DSWD must comply with is ensuring that no candidate or politician is present during the distribution of aid in any form. The Comelec also stressed that politicians should refrain from participating in the distribution of exempted DSWD projects and must not influence the conduct of the elections.

The DSWD assured the Comelec and the public that "mechanisms are in place to ensure that our programs will not be used for political activities." (RMO, PIA Quezon)

DA: Pork prices to decline starting mid-March

MANILA – The retail prices of pork may start to drop in the middle of March, the Department of Agriculture (DA) said on Wednesday.

In an interview, DA spokesperson Assistant Secretary Arnel de Mesa said the high prices of as much as PHP480 per kilogram in February could be considered the peak price before it gradually eases.

"We can see na baba-baba. Iyong last na agreement ng pag-uusap ng agri stakeholders sa hog industry na dapat bumaba ang presyo (The last agreement upon the meeting with agricultural stakeholders of the hog industry include the drop of prices)," he said.

Even without setting the maximum suggested retail price (MSRP) for pork, De Mesa said prices should drop by at least PHP10 to PHP20.

As of March 4, the prevailing price of pork liempo (belly) in Metro Manila is set at PHP450/kg; while PHP380/kg for pork kasim (ham), according to the DA Bantay Presyo.

LGUs now allowed to buy NFA rice on credit, Palace says

MANILA — Local government units (LGUs) can now purchase National Food Authority (NFA) rice on credit, Malacañang announced on Thursday.

This developed after Palace Press Officer and Presidential Communications Office Undersecretary Claire Castro met with Department of Agriculture (DA) Secretary Francisco Tiu Laurel Jr. on Wednesday.

In a press conference, Castro said he conveyed to Tiu Laurel the sentiment of other LGUs that cannot afford to buy NFA rice in bulk.

Castro said LGUs with insufficient funds need to coordinate with the Food Terminal Terminal Incorporated (FTI) for the credit purchase of NFA rice.

"Ang sabi sa atin ni DA Secretary Laurel, puwedeng kumuha ng bigas, utang, kausapin

ang FTI (DA Secretary Laurel told us that LGUs can procure rice through loan and that they have to talk to the FTI)," she said.

"Puwele silang magbayad after. So 'yun po ang good news. Hindi po kailangang maglabas ng cash ang LGUs na hindi po kakayanin na bumili kaagad ng NFA rice. So, maki-pag-ugnayan lang po sa FTI at sila po mabibigyan (They can pay later. So, that's the

good news. LGUs that cannot afford to buy NFA rice right away do not need to come up with cash. So, just contact the FTI and they can avail of the rice)," Castro added.

Castro earlier advised LGUs to sell NFA rice at PHP33 per kg. instead of PHP35 to ease the consumers' plight.

Outpatient mental health package supports Pinoys' 'invisible' pains

MANILA — The Philippine Health Insurance Corporation (PhilHealth) on Tuesday reminded Filipinos experiencing "invisible" pains to avail of the outpatient benefits package for mental health.

The package covers conditions such as depression, psychosis, epilepsy, child and adolescent mental and behavioral disorders, dementia, and self-harm or suicide risks, among others.

PhilHealth Circular 2023-0018 states that members and dependents aged 10 and above can access services like initial assessments, follow-up consultations, diagnostic tests, and psychosocial support.

PhilHealth acting President and chief executive officer Edwin Mercado said the benefit package is aligned with the priorities set by President Ferdinand R. Marcos Jr. in "addressing the healthcare needs of Filipinos holistically."

Castro earlier advised LGUs to sell NFA rice at PHP33 per kg. instead of PHP35 to ease the consumers' plight.

The state insurer provides annual coverage of PHP9,000 for general mental health services and PHP16,000 for specialized care.

Members can access these benefits at any accredited facility that provides general mental health services.

These facilities include rural health units (RHUs), city or municipal health offices, level 1 and 2 hospitals, Department of Health (DOH) Medicine Access Program-mental health access sites, and stand-alone mental health clinics.
