Marcos inaugurates grains terminal, trading project in Batangas City

MANILA – President Ferdinand R. Marcos Jr. on Thursday led the inauguration of the Sorosoro Ibaba Development Cooperative (SIDC) Grains Terminal and Trading Project in Batangas City.

In a keynote speech, Marcos said the new feed mill facility, which has two silos with a total capaci-

ty of 12,000 metric tons of corn, can produce around 480,000 sacks of feed for over 100,000 pigs or almost 600,000 chickens.

“Sa pamamagitan nito, mas magiging maayos ang pag-iimbak ng ating mais. Mas magiging matibay ang ating suporta sa industriya ng poultry at saka ng livestock (Through

this, our corn storage will be better. Our support for the poultry and livestock industries will be stronger,” Marcos said.

DTI empowers sari-sari stores through digitalization

CALAMBA CITY, Laguna (PIA) — The Department of Trade and Industry (DTI) in Calabarzon continues to support micro-retailers also known as sari-sari stores by promoting digitalization through the “Tindahan Mo, e-Level Up Mo” program.

DTI Assistant Regional Director Revelyn Cortez said that DTI’s digitalization efforts are not limited to medium-sized businesses but also include micro-retailers.



She emphasized the agency’s commitment to helping small businesses transition to digital platforms through capacity-building training

sessions designed to enhance their knowledge and skills in e-commerce and digital transactions.

Gov’t urged to fast-track measures on mandatory food warning labels

MANILA – A network of public health advocates and civil society organizations on Wednesday urged the government to implement measures that will protect Filipino consumers from unhealthy food products and noncommunicable diseases (NCDs).

The Healthy Philippines Alliance (HPA) noted these measures include a nutrient profile model (NPM) paired with a mandatory food warning label law.

“We need a robust NPM that sets thresh-

old levels for sugar, sodium, and saturated fats in pre-packaged food products. Those that go beyond the thresholds will be identified through mandatory front-of-pack food warning labels to help consumers

agenda. Even sari-sari stores are now part of this initiative. We provide them seminars on how to order and sell products online, as well as how to better reach their customers through digital platforms,” Cortez said during the Kapihan sa Bagong Pilipinas on March 11.

Since last year, the DTI Calabarzon has been going around the region to roll out the program, equipping micro-retailers with knowledge on the use

of various digital tools.

Training sessions cover topics such as mobile wallets and digital payments in partnership with financial technology providers like Uno Digital Bank and GCash. Entrepreneurs are also introduced to online banking applications, enabling them to open savings accounts and

access loan programs to expand their businesses.

The DTI has also partnered with GCash to introduce the GCash Pera Outlet, to allow sari-sari store owners and retailers earn additional income through digital payment services, cash-in, and cash-out transactions.

di sa buong Calabarzon (And above all, our farmers and our businessmen will have income security, not only here in Batangas, but throughout Calabarzon)," he added.

avoid products that can harm them," HPA lead convenor and former health secretary Jaime Galvez Tan said in a statement.

"These interventions in turn encourage the food and beverage industry to reformulate their products," he added.

The HPA maintains its position for the Philippines to adopt a strong pro-consumer NPM aligned with the Pan American Health Organization (PAHO) Model and the recommendation of the World Health Organization (WHO), citing maximum intake for nutrients of concern—sugar, sodium, and fats—to combat diabetes, cancers, and chronic kidney disease (CKD).

Hospitals urged to submit good claims to ensure faster payments

MANILA — The Philippine Health Insurance Corporation (PhilHealth) on Thursday reminded hospitals and health facilities to submit good claims to receive payments due their services.

In a public advisory, the state insurer said its national turnaround time (TAT) on good claims for 2024 has improved to 24 days from 34 days for 2023.

"This only shows our continuous commitment to processing and payment of good claims ahead of prescribed 60 days TAT," it said.

Good claims are claims without deficiencies and compliant

to all pertinent policies and requirements of the National Health Insurance Program and the Universal Health Care.

"While our benefit payout for CY (calendar year) 2024 increased by 22.71 percent from PHP119 billion in CY 2023 to PHP165 billion for CY 2024, however about 5.3 percent of the claims received, estimated to cost around PHP10 billion were either denied payment or returned to hospitals due to deficiencies or violations of existing policies and guidelines," the PhilHealth said.

Last week, Phil-



Health President and Chief Executive Officer Edwin Mercado said the state insurer will start reprocessing 1.1 million denied claims amounting to PHP8.8 billion from Dec. 1, 2018 to Dec. 31, 2024.

Health facilities are urged to submit good claims earlier than the prescribed 60-day period to further reduce and ensure early release of payment.

PhilHealth vowed to work closely with healthcare providers and other partners through continuous reconciliation to maintain the quality of service and improved financial support value for its members. (PNA)

This indicates that food manufacturers chose reformulation, wherein levels of sugar, sodium, and fats were lowered across several food and beverage products.

The National Kidney Transplant Institute estimates that one Filipino every hour develops CKD.

In 2021, the Philippine Society of Nephrology said at least 7 million Filipinos are diagnosed with CKD.

Additionally, a 2022

study showed that the prevalence of CKD nationwide is at 35.94 percent, which means three in every 10 Filipinos suffer from the disease.

The WHO also reported in 2022 that among the cancer types, colorectal cancer is the third most common among Filipinos, with more than 20,700 cases yearly. It is the fourth cause of death nationwide, claiming about 10,700 lives annually. (PNA)
