Number of ASF-affected barangays in PH drops

MANILA – The number of barangays with active cases of African swine fever (ASF) dropped further by the end of February, the Department of Agriculture-Bureau of Animal Industry reported Tuesday.

As of Feb. 28, red zones or those with active ASF cases dropped to 66 from 68 barangays logged last Feb. 14.

The affected barangays are reported in eight regions including Cordillera Administrative Region (CAR),

Ilocos, Central Luzon, Calabarzon, Mimaropa, Bicol, Central, and Caraga.

The majority of the 42 affected cities and municipalities are reported in Central Visayas, particularly in Bohol including Batuan, Bien Unido, Bilar, Catigbian, Dagohoy, Loon, Panglao, San Miguel, Tagbilaran City, Talibon, Trinidad, and Ubay.

Catanduanes' capital town Virac recorded the highest number of red zones with eight barangays affected;

Food security strengthened with new Batangas grains terminal

BATANGAS CITY (PIA) — The newly opened Grains Terminal and Trading Facility of the Sorosoro Ibaba Development Cooperative is set to enhance the agricultural supply chain and create economic opportunities in Batangas and neighboring provinces.

President Ferdinand R. Marcos Jr. led the inauguration of the



facility on Thursday, March 13. The facility was established under the Department of Agriculture's Philippine Rural Development Project with a ₱270 million investment

from the World Bank. According to the DA, the project will engage in the storage, procurement and trading of yellow corn, which is the major raw material for animal feed

DTI urges Calabarzon LGUs to buy local



CALAMBA CITY, Laguna (PIA) – The Department of Trade and Industry is urging government offices in the Calabarzon region to prioritize local manufacturers in their procurement plans.

Marissa Argente, regional director of DTI Region IV-A, reminded local government units to allocate 10 percent of their annual budget for purchasing local products, as required by Government Procurement Policy Board Resolution No. 11-2021.

Highlighting SIDC's success, President Marcos emphasized the crucial role of cooperatives in strength-

manufacturers," Argente said during the Kapihan sa Bagong Pilipinas on March 11.

Argente noted that local government units have been supportive of the policy, with some allocating more than 10 percent of their procurement funds to local suppliers.

"Local government units have been allocating more than 10 percent of their budget in purchasing from local suppliers. It is indeed true that when we calculate it, a significant allocation comes from our local suppliers."

Under Section 34 of Republic Act No. 11032, local government units are required to allocate at least 10 percent of their budget to purchase from local

12009, more commonly known as the New Government Procurement Act, agencies must secure at least three price quotations for goods not available to the Procurement Service-Department of Budget and Management.

"There is a certain amount that requires public bidding, while there is also an amount categorized as 'shopping' or 'small value procurement' where canvassing is allowed. Hopefully, the items they [government offices] canvass are sourced locally."

The GPPB continues to update Bids and Awards Committees on government

procurement policies, while the DTI encourages government offices to source locally when shortlisting suppliers.

"We have already implemented this understanding across all Bids and Awards Committees under the Government Procurement Policy Board. This serves as an encouragement for the procurement of local goods," Argente added.

The Trade department said it maintains a directory of local manufacturers to assist government offices and local government units in sourcing compliant suppliers. (PB/PI4A)

ening food security and improving the livelihoods of local farmers and fisherfolk.

Mio Takada, World Bank Task Team Leader, said the sub-project goes beyond increasing agricultural productivity, as it also creates numerous job opportunities and provides stable employment in the region.

Medium Enterprises (MSMEs) to a wider consumer base, both locally and internationally.

Highlighting the success of Likhang Laguna, Marissa Argente, Regional Director of DTI Calabarzon,

emphasized the program's vital role in facilitating international market penetration for Filipino-made products. During the Kapihan sa Bagong Pilipinas, she revealed that Likhang Laguna recently generated over P29 million in profits in the United States through on-the-spot sales, booked orders, and ongoing negotiations.

This achievement was made possible through

ulation by middlemen, ensuring fair trade practices.

Batangas City Mayor Beverly Dimacuha recognized the facility's impact on local farmers.

Grace Faraon, President of the Batangas City Corn Growers Association, also welcomed the establish-

their products internationally, particularly to Filipino-Americans interested in importing.

"We also discovered that anything made by Filipinos is something Filipino-Americans really want to try and buy. That's why we realized that penetrating online stores managed by Filipino entrepreneurs will be a fast and effective way of bringing our products to the US," Argente added, underscoring the importance of digitization for international expansion.

These initiatives exemplify DTI's commitment to elevating opportunities for MSMEs through programs like Likhang Laguna, opening new avenues for growth and development on the global stage.

Argente also encouraged the public to support local products, dispelling the notion that they are inferior. She stressed that Filipino-made goods, with programs like Likhang Laguna leading the way, have the potential to gain global recognition, but require strong consumer support. (CO, CH/PIA-4A)

Cavite provincial government disposes valueless office records in compliance with National Archives Act

The Provincial Government of Cavite (PGC) successfully carried out the proper disposal of valueless office records and documents that had reached their records disposition schedule on March 14, 2025. The disposal process took place at the Office of the Provincial General Services Officer (OPGSO), 9*- Provincial Capitol Compound, and Gen. Emilio Aguinaldo Memorial Hospital in Trece Martires City.

The initiative adheres to Republic Act No. 9470, also known as the National Archives of the Philippines Act of 2007, which strengthens the management and administration of archival records through the National Archives of the Philippines (NAP). The disposal strictly followed the provisions of NAP General Circular No. 2, which outlines the guidelines for discarding obsolete government records.

A total of 12,888 kilos of office documents and records, valued at P42,401.52, from various PGC offices were approved for disposal and sold to D' Lacoste Enterprises, a NAP-accredited disposal partner. The proceeds were remitted to the Office of the Provincial Treasurer and will be allocated to support various local government programs.

The activity was witnessed NAP representative Christin E. Licopit, Senior Records Management Analyst, Commission on Audit representative Angelica Mae P. Legaspi, State Auditor I, OPGSO Officer-in-Charge and Records Management Improvement Committee (RMIC) Chair Lu-zviminda S. PhilHealth animal bite package covers P5.8-K in services

MANILA – The Philippine Health Insurance Corp. (PhilHealth) on Tuesday reminded the public to avail of its increased animal bite treatment (ABT) package as the Department of Health (DOH) reported a 100 percent fatality rate for rabies cases.

According to the DOH, the country recorded 426 rabies cases, which resulted in deaths in 2024.

About 193 or 45 percent of these were bites from domestic pets, and of that tally, more than half were of unknown vaccination status.

From 2020 to 2024, a total of 1,750 patients died due to rabies.

"Hinikayat natin ang ating mga miyembro na huwag mag-atubiling magpatingin kung sila ay kinagat o di kaya'y kinalmot ng hayop, alaga man o hindi (We encourage our members to consult a doctor when bitten or scratched by their pets or other animals)," PhilHealth President and Chief Executive Officer

Edwin Mercado said.

"Ang rabies ay isang lubhang nakamamatay na sakit ngunit maaari itong maiwasan kung agarang mabibigyan ng bakuna (Rabies is a deadly disease but it can be prevented through vaccination)," he added.

PhilHealth's ABT package has been raised from PHP3,000 to PHP5,850.

It covers essential post-exposure prophylaxis, including rabies vaccine and rabies immune globulin for immediate protection, local wound care, tetanus toxoid and anti-tetanus serum, and antibiotics. It also covers supplies, such as syringes, alcohol, and antiseptics.

Rabies is a viral disease that comes from the saliva of infected animals and spreads through bites, scratches, or other contact (eyes, mouth, nose, and wound) with the saliva of an infected animal.

Its symptoms include fever, weakness, swell-

ing of wound, fear of air and water, confusion, paralysis, and swelling of the brain and spinal cord.

Symptoms may show two to three months after exposure to rabies. In some cases, symptoms may arise in a few weeks or as long as one year after exposure, depending on the amount of virus that entered the individual's body.

Rabies causes 60,000 to 70,000 reported deaths annually. The Philippines ranks sixth among countries with the highest rabies incidence.

"Ang ABT Package ay maaaring makuha sa higit 700 accredited ABT Package Providers sa bansa, at patuloy pa natin itong dinadagdagan (The ABT package may be availed of from more than 700 accredited ABT providers nationwide, and we're continuing to increase their number)," Mercado said.

He urged everyone to be responsible by having their pets vaccinated against rabies. (PNA)
