## DSWD assures continuous relief support for calamity-hit families

MANILA – Department of Social Welfare and Development (DSWD) Secretary Rex Gatchalian on Tuesday assured continuous relief support for families affected by the combined effects of Severe Tropical Storm Crising (international name Wipha) and the enhanced southwest monsoon or “habagat.”

“Ang instruction ng Pangulo (Ferdinand R. Marcos Jr.), dapat lahat ng naapektuhan, walang magugutom kaya tuloy-tuloy ang

suporta ng pagkain sa ating affected families (The instruction of our President is that all affected should not go hungry, that's why we are continuously supporting the affected families with food),” Gatchalian said during the Presidential Communications Office (PCO) virtual press briefing on the government's response to the effects of habagat.

Data from the DSWD showed that 490,418 families have been affected by the two weather systems, with

14,191 families staying in 500 evacuation centers nationwide.

“Since Crising, we have already released 92,590 family food packs (FFPs) to the local government units (LGUs) who have requested augmentation. And we are set to release around 40,000 additional FFPs for the remaining request of other LGUs,” Gatchalian said.

The DSWD chief reiterated that the agency has prepositioned more than 3 million boxes of FFPs

ahead of Crising and production of food packs continues at the DSWD's main disaster hubs — the NROC and the Visayas Disaster Response Center (VDRC) in Mandaue City, Cebu.

The FFPs, as well as 337,494 non-food items like sleeping kits and hygiene packs, are prepositioned in 935 warehouses across the

country.

“Hindi tayo tumitigil sa pagre-repack. Laging handa ang DSWD na magbigay ng augmentation o karagdagang tulong sa mga LGUs para sa panganagialangan ng mga affected families sa kanilang lugar (We don't stop repacking food [packs].

The DSWD is always ready to provide addi-

tional assistance to the LGUs for the needs of the affected families in their area,” Gatchalian said.

He also cited the innovations implemented under the Marcos administration – the ready-to-eat food (RTEF) boxes and water filtration kits.

Gatchalian assured that the DSWD is

## Gov't aid sent to 4K families affected by Crising, habagat in Calabarzon

CALAMBA CITY, Laguna (PIA) — The Department of Social Welfare and Development (DSWD) in Calabarzon has sent aid to more than 4,000 families affected by the combined effects of Severe Tropical Storm Crising and the southwest monsoon or habagat.

In a social media post on Tuesday, July 22, the DSWD Calabarzon said it has provided over ₱1.29



million-worth of food and non-food items to a total of 4,570 families across the region affected by continuous heavy rains. The majority of those affected

are from Rizal province, with 2,118 families currently taking shelter in 45 evacuation centers.

## Hospitals, evacuation centers priorities for power restoration: DOE

MANILA – The Department of Energy (DOE) has ordered the prioritization of power restoration and maintenance activities in critical areas such as hospitals and evacuation centers as Tropical Depression Dante intensifies rains brought by the southwest monsoon (habagat).

During the meeting of the inter-agency Task Force on Energy Resiliency (TFER) Tuesday afternoon, Energy Secretary Sharon Garin directed the Manila Electric Company (Meralco) to help ensure power sup-

ply, especially in four hospitals identified as vulnerable to severe flooding.

These hospitals were identified as the San Lorenzo Ruiz General Hospital in Malabon, Tondo Medical Center in Manila, Valenzuela Medical Center, and

Council on Tuesday approved resolution PR23CC-054 declaring a state of calamity in the city as recommended by the QC Disaster Risk Reduction and Management Council (QC DRRMC).

In an interview, QC Mayor Joy Belmonte said the state of calamity was declared to fast-track the release and use of emergency funds and not as an indicator of large-scale destruction.

“I would like to just correct ‘yung maling akala ng mga tao pag sinabing state of ca-

lamity, kawawa naman yung lungsod, maraming deaths, maraming destruction. Hindi po 'yan ang ibig sabihin ng state of calamity (the misconception that state of calamity means there are deaths or widespread destruction. That is not what state of calamity means)," Belmonte said.

"Ang ibig sabihin nun ay puwede po natin i-access 'yung tinatawag nating quick response fund, which is 30 percent of our fund, ma-access na mas mabilis para mabilis po ang rehabilitation (What that means is that we can access what we call the quick response fund, which is 30 percent of our fund, so we can access it faster for immediate rehabilitation)."

Belmonte said the city government has already identified three key areas where the quick response fund will be immediately used.

She said the fund would be allotted particularly for the cleanup operation to clear large volumes of garbage and debris left by floodwaters.

She said the city plans to hire more garbage trucks to expedite this effort.

Budget would also be allotted for the repair of damaged minor infrastructures, and for the purchase of essential medicines for evacuees, as over-crowding in evacuation centers has led to increased health concerns.

"Doon po sa tatlong 'yan mapupunta 'yung portion lang naman ng

quick response fund. We will not use all of it kasi mahaba pa ang taon at maaring marami pa tayong kalamidad na maranasan (The budget would go to those three, but only a portion of the quick response fund will be used. We will not use all of it because the year is still long and we may still experience other disasters)," Belmonte said.

In Cavite, Governor Francisco Gabriel "Abeng" Remulla made the announcement in a post on his Facebook page.

"Dahil sa matinding epekto ng habagat na pinalakas ng Severe Tropical Storm 'Crising,' idineklara ng Pamahalaang Pederal ng Cavite ang buong lalawigan sa ilalim ng State of Calamity (Due to the severe effects of the southwest monsoon intensified by Severe Tropical Storm 'Crising,' the provincial government of Cavite is ready to augment the needs of your constituents. Just tell us)," he said.

closely coordinating with the LGUs for a prompt and efficient distribution of augmentation support.

"Sa ating mga LGUs, naniniwala ako na sa pakikipagtulungan sa inyo, mas mabilis na makakarating ang mga relief packs sa lahat ng mga nangangailangan. Meanwhile, in Calumpit, Bulacan, Mayor Lem Faustino cited the flooding caused by the continuous rainfall, high tide, and water release from Ipo Dam as reason for the declaration of state of calamity in the municipality.

In her Facebook post, she said the declaration, through SB Resolution No. 85-2025, was approved by the Sangguniang Bayan upon recommendation of the Municipal Disaster Risk Reduction and Management

zon said it has been monitoring and assessing the situation since the onset of severe weather conditions on Saturday, July 19.

"Since July 19, the DSWD Field Office IV-A, through its Quick Response Teams, has been closely coordinating with local government units (LGUs) to assess the needs of affected families, especially those displaced and currently staying in LGU-run evacuation centers," the agency said.

Aid were also extended in Laurel and Tanauan City in Batangas; Silang, Magallanes, and Ternate in Cavite; Cabuyao City in Laguna; Pitogo in Quezon; and Rodriguez and Taytay in Rizal.

The agency emphasized that it remains

ready to provide appropriate augmentation support to LGUs in need of assistance.

"The DSWD continues to coordinate with all affected LGUs in CALABARZON to determine the needs of affected families and deliver the appropriate assistance."

Sufficient food and non-food items pre-positioned in 69 warehouses across the region are ready for deployment to LGUs requesting support.

In addition to distributing relief goods, DSWD personnel also conduct monitoring and inspections of open evacuation centers in the region to ensure the safety of affected families and to address their immediate needs. (KA, PIA4A)

## DOH sends P31-M worth of emergency medicines, logistics

MANILA – The Department of Health (DOH) has deployed PHP31 million worth of emergency medicines and logistics to flood-affected regions as part of its ongoing disaster response.

In the Presidential Communications Office's virtual press briefing on Tuesday, DOH spokesperson Albert Domingo said the prepositioned supplies are currently being utilized in local government units across Ilocos, Cagayan Valley, MIMAROPA, Western Visayas, Central Visayas, and Northern Mindanao.

The department also has PHP180 million worth of additional emergency supplies on standby, ready for deployment as needed.

Among the medicines and supplies are antibiotics for infections such as co-trimoxazole and amoxicillin, paracetamol and mefenamic acid for fever and pain, skin ointments for common flood-related skin diseases like fungal infections (alipunga), as well as lagundi-based tablets for coughs and colds, and oral rehydration salts (Oresol) for diarrhea.

Evacuees are also receiving hygiene kits, breastfeeding kits, drinking water containers, and chlorine tablets to purify contaminated water.

Domingo reminded the public to boil water for at least two minutes if chlorine tablets are unavailable to prevent waterborne illnesses.

“Kung tayo man po ay napalusong sa baha kasama po ang ating mga kasamahan sa gobiyerno kasama po ang mga rescuers, andito po ang DOH at mga LGU (local government unit) doctors, puwede po namin kayo resetahan ng prophylaxis para hindi kayo magkaroon ng leptospirosis (If we happen to wade through floodwaters together with our fellow government workers and rescuers, the DOH and LGU doctors are here and can prescribe you prophylaxis to prevent leptospirosis),” he said.

Domingo warned that symptoms of leptospirosis typically appear two weeks after exposure and resemble flu-like illnesses such as fever and muscle pain. More severe signs include jaundice or yellowing of the skin and eyes, and darkened stool as it can affect the kidneys, liver, lungs, heart, and even the brain.

The Metro Manila Development Authority and other groups involved in clearing operations are also advised to wear boots and take precautionary medication even if they did not encounter floods, as even soil or mud can contain leptospirosis bacteria.

In compliance with President Ferdinand R. Marcos Jr.'s directive, DOH officials and local government doctors are continuously monitoring evacuation centers to ensure the health and well-being of displaced residents.

Health Secretary Ted Herbosa personally visited Marikina on Monday morning, specifically Nangka Elementary School, where 502 families or 2,407 individuals are currently staying, and H. Bautista Elementary School, which houses 603 families or 3,880 evacuees. He assessed the other needs of the evacuees, including the condition of WASH



**Cavite empowers people through integrated compassionate cancer care.**

Remulla addressed the battles and challenges many people face against cancer, and underscored the importance of cancer care, stating “It is imperative that we give significance to cancer care through raising awareness, and empowering people with compassion.”

Afterwards, Atty. Allan Chester Nadate, House of Representatives Director II, shared a keynote lecture on National Integrated Cancer Control Act Law and emphasized the collective effort of everyone to increase the level of health awareness and empowerment. “Ang bawat isa sa satin ay mayroong papel at mayroong ginagampanan para makaligtas ng buhay”, he remarked.

The convention featured a series of lectures and discussions that aimed to inspire attendees and underscore the holistic and compassionate approach on oncology and cancer care.

As the event came to an end, Dr. Warren Bacarri, Philippine Society of Oncologists, Inc. President, urged for a solidified effort to fight against the disease, with a call for united action, “Samasama nating sugpuin ang cancer”.--- OPIO

(water, sanitation, and hygiene) facilities and the nutritional value of the meals being served, in addition to the emergency commodities already provided by the agency.

The DOH has already distributed essential medicines such as doxycycline (for leptospirosis prevention), maintenance drugs for diabetes and hypertension, antibiotics, cough medicine, first-aid kits, vitamins, and facemasks.

“Coughs and colds

are the most common illnesses we're seeing in these evacuation sites,” Herbosa said.

He advised them to practice frequent handwashing and wear facemasks to prevent the spread of infection.

The DOH said it continues to work closely with LGUs and other government agencies

to ensure the safety and health of evacuees as the country responds to severe weather events and their aftermath.

Marcos has issued a firm directive to prepare for all aspects of emergency response this rainy season, especially in flood-prone areas. (PNA)

## DSWD assists 1.8M individuals in crisis situations across Calabarzon

CALAMBA CITY, Laguna (PIA)—Over 1.8 million Calabarzon residents have received financial aid from the Department of Social Welfare and Development (DSWD) since 2024 under its Assistance to Individuals in Crisis Situations (AICS).

The program aligns with the directive of President Ferdinand R. Marcos Jr. to ensure the swift and efficient delivery of aid, reaffirming the "Bawat Buhay Mahalaga" vision of Bagong Pilipinas.

According to DSWD Calabarzon, a total of 1,833,996 individuals have been provided with financial support since 2024 to help them cope with various economic shocks such as illness, hospitalization, or the death of a family member. Of this number, 587,000 individuals were assisted in the first half of 2025.

"If there's death in the family or hospitalization, you can't prepare for it, so we are helping them get back on track and recover. With the assistance that we give, it will help them be productive, start anew, and provide again for their needs," said Regional

Director Barry Chua of DSWD Calabarzon.

DSWD emphasized that the provision of financial assistance under the program is based on the assessment and interview conducted by social workers, as well as the status of the clients.

According to DSWD data in 2024, a total of 1,246,996 individuals were assisted through the AICS program, with a total amount of P5.13 billion disbursed to cover medical, subsistence, burial, and educational needs.

To enhance the efficiency of aid delivery, DSWD partnered with the Land Bank of the Philippines and the Universal Storefront Services Corporation (USSC) to implement hybrid digital payments and streamlined disbursement methods.

"We started the implementation of hybrid digital payment of financial assistance in Batangas City last January 17, 2025, with 577 clients receiving a total of 1.8 million in medical or burial assistance.

This is for efficient disbursement and minimizes security risks for DSWD personnel by handling large amounts

Amang Rodriguez Memorial Medical Center in Marikina, the DOE said in news release Tuesday night.

DOE's Electric Power Industry Management Bureau (EPIMB) was also ordered to coordinate with Meralco "to conduct site inspections of the four high-risk hospitals and provide

technical assistance to improve their flood-related electrical resiliency."

Meralco was also tasked to help provide necessary power supply to the Roman Tantiongco Memorial Elementary School in Sitio Wawa, Barangay San Juan in Morong, Rizal, which is now being

Through guarantee letters (GLs), the AICS program now allows access to medical assistance via selected branches of the leading drugstore chain, Mercury Drug. These GLs ensure that the government covers the cost of products and services, including medicines, provided by partner service providers.

"In Calabarzon there are five participating Mercury Drug outlets accepting guarantee letters, including Bayanan in Bacoor City, P. Guevarra Sta. Cruz in Laguna, Kumintang Ilaya in Batangas City, Cathedral in Antipolo City, and Merchan in Lucena City."

The National Electrification Administration (NEA) was also tapped to closely monitor and validate power status in areas affected by the weather disturbances.

One of the AICS beneficiaries, Donna Talucod, 43, a resident of Victoria, Laguna, whose husband is a kidney transplant patient, expressed gratitude to the government for the help provided by the program.

"The assistance I received through GL helped me ease the financial burden on my shoulders, and getting the medicines at the nearest Mercury Drug assured me of quality medicine. This is such a big help," Talucod said.

Chua reaffirmed DSWD Calabarzon's commitment to assisting individuals and families through its social protection programs, underscoring the agency's goal to uplift those in crisis situations. (KA, PIA4A)

## Proposed educational module pushes for environment conservation in San Juan, Batangas



SAN JUAN, Batangas (PIA)—Wildlife conservationists are pushing to include lessons on environment conservation for the youth of San Juan, Batangas.

## House now 90-95% ready for PBBM's 4th SONA

MANILA – The House of Representatives on Monday said it is now “90 to 95 percent ready” to host President Ferdinand R. Marcos Jr.’s fourth State of the Nation Address (SONA) at the Batasang Pambansa complex in Quezon City.

House spokesperson, lawyer Princess Abante, made the announcement following the final interagency coordination meeting held earlier in the day to finalize preparations.

“From the discussions I heard earlier, siguro mga nasa 90 to 95 percent na tayo (we are about 90-95 percent) ready, leaving room for some adjustments,” Abante said in a press briefing.

“Just some matters na lang na kailangan i-check (that needed to be checked). I think in a while the interagency delegation will have a walk-through in the House of Representatives. But other than that, we are all set,” she added.

Abante said the House is now in the final stretch of SONA preparations, with all agencies involved closely monitoring weather conditions and fine-tuning con-

tingency plans.

Despite intermittent rains and prevailing weather systems in recent days, she clarified that these have not caused any disruption.

## Strong Group-PH beats UAE to complete Jones Cup title sweep

MANILA – Strong Group-Philippines defeated United Arab Emirates, 87-62, Sunday, wrapping up the William Jones Cup campaign, with an 8-0 record, at the Xinzhuang Gymnasium in New Taipei City, Taiwan.

Tanjuan Agee finished with 20 points, five rebounds and four assists, while Kiefer Ravena chipped in 13 points, including three triples, to go with nine assists.

DJ Fenner and Ian Miller scored 12 points each, with Dave Ildefonso contributing 10.

The win sealed a historic feat, making Strong Group the first Philippine team to win back-to-back titles in the tournament’s 44-year history.

The Philippines now boasts eight Jones Cup titles, joining previous champions Northern Cement (1982), San Miguel (1985), the Centennial Team (1998), Gilas Pilipinas (2012), Mighty Sports (2016, 2019), and Strong Group (2024).

Coach Charles Tiu praised the team’s chemistry and dedication.
