# Taal Volcano produces brief phreatomagmatic burst

MANILA – Taal Volcano generated a short phreatomagmatic burst on Wednesday morning, producing grayish plumes that rose above the main crater.

In a Facebook post, the Philippine Institute of Volcanology and Seismology (Phivolcs) reported that the event occurred from 6:51 a.m. to 6:54 a.m.

The plumes, which reached up to 2,800 meters high, drifted northeast, as captured by its Lower Calauit

and Napayong monitoring cameras.

Phivolcs defines phreatomagmatic eruption as the interaction of magma with water, generating steam, ash, and fragmented volcanic material.

This is different from a phreatic eruption, which occurs when water comes into contact with hot rocks or gases, resulting in steam plumes without direct involvement of magma.

Taal's last phre-

tomagmatic activity occurred when three phreatomagmatic bursts and one phreatic event were recorded at the northeastern portion of the main crater between the afternoon of Oct. 25 and the early morning of Oct. 26.

It remains under Alert Level 1, which indicates an abnormal condition but no imminent eruption.

Despite this, Phivolcs warned that sudden steam-driven or phreatic explosions, volca-

nic earthquakes, minor ashfall, and lethal gas accumulations may still occur in the Main

Crater area.

## DSWD to prioritize cash aid for houses 'significantly' damaged by Uwan

MANILA – The Department of Social Welfare and Development (DSWD) is prioritizing the distribution of monetary aid under the emergency cash transfer (ECT) program to families whose homes sustained significant damage from the recent typhoon.

DSWD Secretary Rex Gatchalian gave the assurance on Wednesday during his visit to Aurora province, where he met

with local officials at the Provincial Conference Hall in Baler to discuss the distribution of ECT and other needed assistance in the aftermath of Super Typhoon Uwan (international name Fung-wong).

"Alam kong it's a thankless job iyong pagtukoy doon sa mga partially damaged houses [at] totally damaged, iyon ang laging pinaka-marami. But then again, gawin po nating matiwasa

at maayos ang [assessment]. Pakiusap natin sa mga mayors ay tingnan ng mabuti lalo na iyong mga nan-gangailangan kasi iyan po ang tututukan natin (I know it's a thankless job to identify the partially and totally damaged houses. But let's make a proper assessment. I call on the mayors to properly find those who are really in need because we will prioritize them)," Gatchalian told the lo-

## DOH, WHO target 12M Filipinos to be screened for TB by 2026

MANILA – The Department of Health (DOH) and the World Health Organization (WHO) are ramping up efforts to eliminate tuberculosis (TB) in the Philippines, aiming to screen 12 million Filipinos nationwide by 2026.

In a news release Wednesday night, the DOH said the initiative is under the newly approved Philippine Strategic TB Elimination Plan Phase 2 2025 to 2030.

Developed in line with President Ferdinand R. Marcos Jr.'s

directive to intensify the fight against TB – from prevention to treatment – the plan aims to expand the reach and efficiency of TB services.

The DOH's proposed 2026 budget under the National Expendi-

## No oil spill detected from LCT Felicity 8 – PCG

LEMERY, Batangas (PIA) – The Philippine Coast Guard (PCG) confirmed that no oil spill was detected from LCT Felicity 8, which ran aground off the coastal waters of Lemery, Batangas amid strong winds and currents brought by Super Typhoon Uwan on Saturday, November 8.

In its report, the PCG confirmed that LCT Felicity 8 was sheltering at Pagapas Bay in Calatagan amid poor weather conditions



when it drifted towards shallow parts of the bay.

Operated by Silver Sand Shipping Corporation, the incident was initially reported by the barangay chair of neighboring Baran-

gay Wawa Ilaya to the Coast Guard Sub-station (CGSS) in Lemery.

The Lemery CGSS assured that LCT Felicity 8 was found stable with no significant

ture Program allocates PHP4.2 billion for TB programs, nearly double the PHP2.6 billion earmarked in 2025.

Health Secretary Teodoro Herbosa said the country is leveraging technology and innovation to accelerate TB detection and treatment.

Ultra-portable AI-powered chest X-rays and WHO-recommended Nucleic Acid Amplification Tests are being used to quickly screen and diagnose TB cases.

He added that an innovative all-oral regimen for drug-resistant TB cuts treatment time from two years to only six months.

The DOH also reported a more than 50 percent increase in enrollment for Tuberculosis Preventive Treatment (TPT) in 2024, boosted by shorter TPT regimens and expanded contact investigation. The TPT program has been extended to cover contacts of drug-resistant TB cases and is now under advanced programmatic implementation.

Children with non-severe, drug-susceptible TB are now benefiting from shortened treatment courses – four months instead of six – under the 2HRZE/2HR regimen.

The DOH continues to promote awareness and early treatment through expanded social and behavior change campaigns, including the TPTodo caravans, which educate communities on preventive treatment

and the importance of early care-seeking.

The national campaign is guided by the Philippine Acceleration Action Plan for Tuberculosis, which unites government agencies, civil society, and private partners in the goal of eliminating TB by 2035.

WHO acting representative to the Philippines Dr. Eunyoung Ko described tuberculosis as a global challenge and progress in any country as a means of bringing the world closer to ending the disease.

He said that the WHO remains steadfast in its support for the DOH at both the central and subnational levels as places like Guimaras aim to become the country's first TB-free island.

Globally, an estimated 10.7 million TB cases were recorded in 2024, with 6.8 percent in the Philippines, equivalent to 625 Filipinos developing TB per 100,000 population. Despite TB remaining one of the leading causes of death in the country, claiming about 98 lives daily, the figure marks a 3 percent reduction from the previous year.

Through stronger funding, innovative screening technologies, and sustained community engagement, the DOH and WHO reaffirmed their commitment to curb TB transmission, improve treatment outcomes, and move closer to ending tuberculosis in the Philippines by 2030. (PNA)

cal chief executives of Aurora.

He told the mayors that President Ferdinand R. Marcos Jr. has always emphasized the significance of cash assistance in helping Filipinos recover and rebuild their lives.

"The favorite line of President Marcos is 'not all the needs of the people can be found in the relief packs.' So, we have to start talking about cash assistance," Gatchalian said.

Under the ECT program, beneficiaries with partially-damaged houses will receive PHP5,000, while those with totally-damaged houses will receive PHP10,000.

Social workers from the Municipal Social Welfare and Development Office will assess the extent of the damage to determine the amount to be provided.

Gatchalian clarified that this cash aid is intended as partial assistance and that additional support may still be given.

"I know it's not enough. Pauna lang (It's only an initial amount). We can also come back for recovery so we can augment. What is important is we are acting on

their concerns rather than having them wait for a long time," the DSWD chief said.

Among those who attended the meeting were Gov. Isidro Galban, Rep. Rommel Angara of Aurora's lone district, and DSWD officials led by Undersecretary Diana Rose Cajipe, Assistant Secretary Irene Dumla of the Disaster Response and Management Group and Assistant Secretary Paul Ledesma of the Office for Special Concerns.

Gatchalian later visited Barangay Gupa in Dipaculao to assess the extent of damage caused by the super typhoon.

He also supervised the ongoing relief operations, including the distribution of 500 boxes of family food packs, hygiene kits and sleeping kits.

The DSWD chief personally distributed food packs and hot meals from the DSWD's mobile kitchen, while taking time to check on the well-being of residents.

To date, more than 29,000 food packs have been distributed to various barangays in the ongoing relief efforts.



**PhilHealth to reprocess denied hospital claims starting Nov. 15**

MANILA – The Philippine Health Insurance Corporation (PhilHealth) on Tuesday said it will begin reprocessing previously denied hospital claims starting Nov. 15 until Mar. 31, 2026. Alam nating matagal nang hinaing ng mga ospital ang denied claims (We understand that hospitals have long raised concerns about denied claims),” he said in a statement.

These include denied claims that were unprotested or unappealed and were filed late between Jan. 1, 2018, and Dec. 31, 2024. He explained that some of them were not paid due to submission past PhilHealth’s deadline or other administrative reasons.

“Hindi fraudulent claims ang mga ito at muling ipo-proseso (These are not fraudulent claims and will be reprocessed),” he added.

PhilHealth President and Chief Executive Officer Edwin Mercado said the move acknowledges the challenges faced by hospitals in claim processing. Citing that PhilHealth is committed to delivering

## International Energy Agency warns of new risks in 'age of electricity'

ISTANBUL — The International Energy Agency (IEA) has warned that the global energy system faces its "broadest test in decades," as overlapping risks stretch from fuel markets to supply chains and digital infrastructure.

In its World Energy Outlook 2025, released Tuesday, the Paris-based agency said the world has entered what it calls the "Age of Electricity" -- a period when power demand is rising faster than total energy use, reshaping economies and exposing new vulnerabilities.

"The world has never faced energy security pressures across so many fronts at once, from oil and gas to grids, data, and minerals," IEA Executive Director Fatih Birol said.

He urged governments to show the same determination that led to the agency's creation after the 1973 oil crisis.


Electricity now accounts for one-fifth of all final energy use but powers more than 40 percent of global economic activity, according to the report.

Birol said the transformation is accelerating faster than expected: "Last year, we said the world was moving into the Age of Electricity, and it's clear today that it has already arrived."

Unlike previous decades, the surge in power use is now driven by advanced economies rather than emerging ones. Data centres and artificial intelligence have become major energy consumers, with global investment in digital infrastructure forecast to hit USD580 billion in 2025 -- surpassing spending on oil supply.

"Those who say 'data is the new oil' can now back it up with numbers," Birol added.

### new fault line

The report highlights critical minerals as the next major chokepoint in energy security. One country currently refines 19 of the 20 key energy-related minerals, controlling roughly 70 percent of global processing -- a concentration the IEA warns could expose economies to disruption or coercion.

"These minerals are the foundation of batteries, wind turbines, solar panels, and AI hardware," the agency said, noting that over half now face export restrictions.

"Diversifying and securing these supply chains will require stronger policy coordination, not just market forces."

Birol said minerals have become "what oil was in the 20th century -- a matter of national resilience."

### Emerging economies drive new growth

The IEA projects that India and Southeast Asia will overtake China as the main engines of global energy demand in the next decade.

By 2035, around 80 percent of consumption growth is expected to come from regions rich in solar potential, accelerating the adoption of renewable technologies.

Solar photovoltaic energy remains the fastest-growing power source, while nuclear energy is poised for a revival. Global nuclear capacity is forecast to

expand by at least one-third by 2035, driven by new small modular reactors designed to supply energy-intensive data centers.

Oil and gas markets, the agency said, are currently well-supplied, with prices expected to remain around USD60–65 per barrel. A new wave of liquefied natural gas (LNG) projects is set to boost capacity by 50 percent by 2030, though the IEA warned that "geopolitical risks remain acute" and complacency could destabilize markets.

### Climate goals off track

Despite record growth in renewables, the world remains off course to meet global climate and energy access targets, the report said. About 730 million people still live without electricity, and nearly 2 billion rely on unsafe cooking fuels.

The IEA's updated roadmap calls for full electricity access by 2035 and universal clean cooking by 2040, largely through liquefied petroleum gas (LPG) and decentralized power systems.

Yet even with accelerated efforts, global temperatures are projected to rise beyond 1.5C marking what Birol described as a "critical decade" for governments to act.

"The choices made this decade will shape energy security and climate stability for generations," he said. "The data show the path forward, but also the urgency to move." (Anadolu)

## Estrada seeks Senate commendation for PH team in Asian Youth Games

MANILA – Senator Jinggoy Estrada on Wednesday filed a resolution commending the 141-strong Philippine delegation at the recently concluded Asian Youth Games (AYG) 2025 in Bahrain for delivering the country's biggest medal haul and best-ever performance in the continental sports event.

The Philippine team finished 12th overall with a total of 24 medals - seven gold, seven silver, and 10 bronze.

"This is a proud moment for Philippine sports. Our young athletes have proven that with discipline, dedication, and heart, they can stand tall among the best in Asia. Their victory in Bahrain is a shining testament to the strength of our youth and the bright future of Philippine sports," Estrada said Wednesday after filing Senate Resolution No. 167.

The country's delegation competed in 18 sports disciplines -- including volleyball, athletics, boxing, swimming, taekwondo, jiu-jitsu, weightlifting, and teqball -- finishing second-best in Southeast Asia, next only to Thailand.

Estrada noted that the athletes' record-breaking achievement surpassed previous Philippine performances in the 2013 AYG in Nanjing, China; and the 2009 inaugural games in Singapore,

## Hidilyn Diaz banners PH weightlifting team to Thailand SEA Games

MANILA – Nine weightlifters, led by Olympian Hidilyn Diaz-Naranjo, will compete in the Southeast Asian Games (SEAG) in Thailand next month.

Diaz-Naranjo, who delivered the country's first gold medal (55kg) at the Tokyo Olympics, will see action in the 58kg category.

Others in the roster are Rosegie Ramos (W 48kg), Jhodie Peralta (W 53kg), Elreen Ann Ando (W 63kg), Kristel Macrohon (W 69kg), Fernando Agad Jr. (M 60kg), Dave Lloyd Pascaldo (M 65 kg), Albert Ian Delos Santos (M 71kg) and John Dexter Tabique (M 94kg).

Naranjo-Diaz won back-to-back gold medals in the SEAG held in the Philippines (2019) and Vietnam (2021), but skipped the Cambodia edition (2023) to focus on the Asian Championships, one of the qualifying events for the 2024 Paris Olympics.


Peralta pocketed two medals, a gold (snatch) and bronze (clean and jerk), at the 3rd Asian Youth Games in Bahrain last month, while Ando, a two-time Olympian, won the bronze medal at the 2025 IWF World Championships in Forde, Norway.

Macrohon, a gold med-

alist at the 2019 SEAG, tallied 236 kg. (105-131) to win three bronze medals at the Asian Weightlifting Championships in Zhejiang, China last May. The Philippines also secured seven silver medals -- three each from Ando and Ramos, and one from Agad.

Delos Santos is optimistic about his debut in the SEAG, scheduled from Dec. 9 to 22.

"It's a dream to win the gold medal in the SEA Games. I will do my best to make it happen," the second year financial management student from Universidad de Zamboanga said in an interview Thursday.

Despite missing the podium at the World Youth and Junior Championships in Forde, Norway last Oct. 6, Delos Santos registered a world junior record of 185kgs on his third attempt in the clean and jerk, finishing eighth in the men's 71kg

support helped propel the athletes to victory.

Estrada said the athletes' triumph "heralds a bright future for Philippine sports," as he called on both the public and private sectors to continue supporting youth development programs and sports excellence initiatives.

"Their story is one of hope, resilience, and national pride — a reminder that the Filipino spirit, even at a young age, is truly world-class," he said.

The AYG is a quadrennial multi-sport event organized by the Olympic Council of Asia for athletes aged 14 to 17, recognized

At the World Youth and Junior Championships in Lima, Peru last May, he pocketed the Juniors 67kg title with a total of 309kgs (134-175).
