DepEd budget to address classroom backlog, boost learners' nutrition

MANILA – Senator Bam Aquino said Tuesday that the approved PHP1.38 trillion allocation for the Department of Education (DepEd) for 2026 would solve the classroom backlog and boost student nutrition.

In its version of the 2026 national budget, the Senate allotted almost PHP70 billion in additional funding for education.

Funding for classroom construction was raised from PHP13.2 billion in the National

Expenditure Program (NEP) to PHP65.9 billion, a PHP52.7 billion increase.

Meanwhile, the Senate is pushing to increase the school-based feeding program budget from PHP11.7 billion to PHP28.6 billion, a jump of PHP16.9 billion.

Aquino said the Senate version of the budget builds a strong case for addressing the backlog, which needs about PHP540 billion to fully resolve.

At present, the coun-

try has a backlog of 165,000 classrooms, which could grow to more than 200,000 within three years if left unaddressed.

Aquino said the budget for classroom construction would be implemented through multiple modalities, including those under the Classroom-Building Acceleration Program (CAP) Act, which allows DepEd to partner with local government units and civil society organizations in constructing

room construction, including those undertaken by the Department of Public Works and Highways and PPP implementers.

"At the price of less than PHP2 million (per classroom), we go from 23,000 to 32,000 (classrooms). If we're able to address the disparity, mas marami rin tayong magagawa (We can construct more)," he said.

On student nutrition, Aquino said the higher appropriation would allow the school-based feeding program to ex-

pand from 120 to 200 feeding days.

"Lahat ng Kinder, lahat ng Grade 1, mayroon tayong pagkain para sa kanila for 200 days (All Kinder, all Grade 1 students, we can provide them food for 200 days)," he said.

For Grades 2 to 6 students, the program will target "wasted and severely wasted" learners.

The expanded feeding program will benefit an estimated 3.5 million students, he said. (PNA)

sustain the province's cultural and economic growth.

The initiative is among the priority programs identified by Governor Sol Aragones, who said she seeks to strengthen faith, preserve Laguna's heritage, and attract more visitors as the province positions itself as a heritage-rich destination and a living sanctuary where faith and tradition converge.

Known for its rich history and spiritual significance, the Pila church will serve as the central venue for the launch, bringing together pilgrims, local officials, and community members in a celebration of faith and heritage.

According to the Laguna Provincial Information Office (PIO), the pilgrimage route will proceed to several notable churches in the province, including the Minor Basilica and Parish of Saint Gregory the Great in Majayjay—recently elevated to the rank of basilica by the late Pope Francis—and the Saint Peter of Alcántara Parish Church in Pakil, renowned for the miraculous image of Our Lady of Turumba.

The route will also include the Nuestra Señora de Candelaria Parish Church in Mabitac, famous for its

126-step stairway that offers pilgrims a serene space for reflection while overlooking Laguna's scenic landscape.

Traders and exhibitors from various localities are expected to participate in the Laguna Tourism Bazaar, to be held alongside the launching event.

"This milestone is not just an event—it is a celebration of the stories, devotion, and cultural identity that continue to shape the heart and soul of Laguna. Join us as Laguna strengthens its identity as a home of faith, history, culture, and living traditions—inviting travelers, pilgrims, and culture bearers to experience stories written across centuries," the tourism office said in a statement.

The provincial government encourages

all parishes, civil society organizations, tour operators, and Catholic pilgrims to actively support and take part in the program.

Key warning signs

that require immediate medical attention include persistent cough, coughing up blood, difficulty breathing, chest tightness or pain, recurrent lung infections and sudden weight loss. Meanwhile, the Philippine Health Insurance Corporation Inc. said the Z Benefit package for lung cancer is in the pipeline.

However, lung cancer patients may avail of the benefit packages for chemotherapy. (PNA)

Vax experts: Immunization can end deadly diseases

MANILA – Vaccination saves lives and every Filipino deserves access to scientifically proven safe and effective vaccines in the fight against some of the world's deadliest diseases.

During a recent media roundtable of the 26th Philippine National Immunization Conference in Pampanga, pediatric infectious disease expert Dr. Josefina Carlos and Philippine Foundation for Vaccination (PFV) president Dr. Rose Capeding vouched for the proven safety and efficacy of vaccines.

"If we are able to save families [through vaccination], then everyone can be happy. If we don't get sick, then we are able to save. Immunization becomes an investment for our health," Carlos said.

Carrying the theme "Advancing Better Immunization for Every Filipino," the conference gathered some of the country's top experts in infectious diseases, public health, and vaccinology for two days of learning with healthcare professionals.

The roundtable discussion "Novel Vaccine Advocacy and Public Health Priorities" included discussions on new vaccines for shingles and dengue.

PFV organized the event in partnership with Takeda Philippines, a company committed to advancing better health through innovative and science-based treatments.

Based on World Health Organization (WHO) data, vaccination saves an average of six lives every minute.

In the past 50 years, the WHO estimates that vaccination saved 154 million lives worldwide, most of them children.

In recent years, however, public trust in vaccination has been threatened by misinformation, particularly unverified or outright fake news found online.

On the brighter side, recent reports indicate that vaccine acceptance among Filipinos has been improving, with initial information showing the country is overcoming vaccine hesitancy. This is why the PFV has been active in its advocacy to provide accurate and science-backed information on vaccines and vaccine-preventable diseases.

"The Philippine Foundation for Vaccination is an advocacy group whose aim is for vaccination to become an essential part of protection for every Filipinos ... in different stages of life -- infancy, childhood, adolescence, adulthood, and for the elderly. It's a life course [approach]," Capeding said.

PFV's advocacy covers not just families, but also the media and fellow doctors. The WHO recognizes the expertise of the group.

"PFV is a member of WHO's Vaccine Safety Net. Together with China, we are recognized by the WHO [providing] credible, science-based information regarding vaccination," Capeding said.

Awareness on shingles

The vaccine experts likewise issued a warning on the burden of shingles or herpes zoster, a viral infection caused by the varicella zoster virus (VZV), which also causes chickenpox.

More than 90 percent of adults 50 years and older are VZV carriers. The risk of developing shingles increases as they get older, if they are immunocompromised, or if they have a history of chickenpox.

Patients with shingles experience skin sensitivity, tingling, itching or pain, followed by skin rashes that turn into blisters. Some patients experience long-term, debilitating nerve pain.

Shingles vaccination, which is already available in the Philippines, has been shown effective

against shingles and its complications, including long-term nerve pain.

Dengue cases

The doctors also addressed media questions on dengue and the importance of vaccination in integrated disease control and prevention.

The Philippines is one of the countries in the world where dengue is endemic. DOH surveillance data from January to Sept. 20 recorded 234,855 cases, with 912 deaths.

The Department of Health (DOH) recorded a decrease in dengue cases for the period Oct. 12 to 25, but emphasized the need for heightened vigilance as the country recovers from recent floodings.

The DOH said 14,038 dengue cases were logged from Oct. 12 to 25, an eight-percent decrease from the 15,182 cases logged Sept. 28 to Oct. 11.

Of the newer vaccines, Takeda's dengue vaccine, TAK-003, has demonstrated protection against all four serotypes of dengue.

Based on TAK-003's safety and efficacy data, the WHO has included it on its list of prequalified vaccines, recommending it for specific age groups living in areas where there is a high dengue burden.

It is also the first approved dengue vaccine in the European Union for individuals regardless of previous dengue exposure. Since 2022, it has been approved in 41 countries and 20 million doses have been dis-

tributed in 11 endemic countries as of September 2025.

The pivotal Phase 3 Tetraivalent Immunization against Dengue Efficacy Study (TIDES) trial, which recently released TAK-003 data covering seven years, reinforced the vaccine's long-term safety profile and confirmed that the two-dose regimen provides sustained protection against dengue.

The Philippines is one of the dengue-endemic countries participating in the TIDES trial. TAK-003 is currently under review by the Food and Drug Administration.

"We should be prepared for the next pandemic. What could be the next pandemic? It could be dengue," PFV executive director Dr. Lulu Bravo, who joined online, said.

She said dengue is more prevalent globally.

"It used to be only in tropical countries like the Philippines. But now, more than 130 countries are affected by dengue," she said.

The PFV and its allies assure the public that they will continue to work to provide science and evidence-based, accurate information on vaccines, to inspire vaccine confidence and contribute to public health improvements.

"The Philippine Foundation for Vaccination is calling for action for everyone, including [the] media, to become vaccine warriors. Let us all work together to become vaccine champions," Bravo said. (PR/PNA)

CCC honors women, youth climate resilience champions

MANILA – The Climate Change Commission (CCC) honored exceptional women and youth leaders advancing local climate action during the 2025 Philippine Resilience Awards (PRA) on Monday in Manila.

In his speech, CCC Vice Chairperson and Executive Director Robert E.A. Borje said community-grounded leadership is central to building national resilience, noting the “true test of resilience is not how often we rebuild, but how rarely we are broken”.

He described the honorees as central to the country’s climate response: “They are the micro-entrepreneurs, scientists, custodians of traditional knowledge, and community organizers who prove that women and youth are not on the sidelines of climate action — they are at the heart of it.”

Borje called for a shift from reactive recovery to proactive protection and urged partners to expand community-driven innovations, noting that isolated “islands of success” are not enough for an archipelagic nation facing escalating climate threats.

Among the women

awardees were Dr. Diana Rose Cajipe for “Buong Bansa Handa,” Jenelyn Salimbagat for her Family Emergency and Disaster Preparedness Plan, and Renebelita Fuentebella for “Damit Dignidad Pilipinas.”

Five youth champions were likewise recognized: Raymart Garcia for the Reskyusi Food Basket Program, Shri Tahanie Macaumbao for Green by Design, Val Amiel Vestil for “Kwentong Kalikasan,” Peter John Enorio for his Subang Environmental Initiatives, and Christian Hernandez for Project MOSES.

Borje underscored that resilience is built

on science, purpose, planning, and action—not sentiment—and affirmed the CCC’s commitment to scaling successful community models nationwide.

“Masakit man na nagkakaroon tayo ng losses and damages, but hindi pwedeng mapako tayo sa (It is painful that we are suffering losses and damages, but we cannot be nailed to the) losses and damages. We do have to transform into something more resilient. And we can only do that if we keep on doing our part, not just today, not just within our communities, but beyond,” Borje said. (PNA)
