## Public urged to opt for chicken as price of 'GG' surges

MANILA – Agriculture Secretary Francisco Tiu Laurel Jr. on Wednesday advised consumers to consider more affordable fish options amid a tight global supply of galunggong (round scad), which has pushed retail prices higher in local markets.

Data from the Department of Agriculture's Bantay Presyo monitoring showed that as of Monday, imported galunggong in Metro Manila was priced between PHP280 and PHP350 per kilogram,

while locally sourced galunggong ranged from PHP300 to PHP400 per kilogram.

In an ambush interview, the agriculture chief said the limited arrivals of round scad from major sources have driven prices upward.

"It's really a supply and demand situation. If supply is scarce, prices will increase," he said in Filipino.

"I'm not saying prices will go down soon. If it's too expensive, you can opt for chicken instead."

He also mentioned other fish alternatives for buyers, considering the high retail price of round scad.

"We still have milkfish, tilapia, let's not forget our own," Tiu Laurel said.

Besides galunggong, the DA also logged elevated prices for mackerel or alumahan, which range from PHP300 per kg to PHP450 per kg.

Tiu Laurel, however, expects prices to decline to around PHP230 to PHP250

In response, the municipal government approved two significant resolutions to strengthen monitoring, coordination, and public awareness on safe water use.

Municipal Councilor and Committee on Health, Nutrition and Sanitation Chairperson Muriel Laisa Dizon said the resolutions

are a proactive move to prevent potential health emergencies and ensure that the municipality responds swiftly to any threat to public safety.

The first resolution directs closer coordination between UPLB and the municipality for the joint identification and assessment of artesian wells, formulation of management recommendations, provision of assistance

In a statement, the Department of Labor and Employment (DOLE) reported that from Kanlaon's eruption earlier this year to the most recent typhoons, they have delivered a total of PHP2.045 billion in TUPAD assistance across hard-hit areas throughout the country.

A total of 381,513 individuals nationwide benefitted from the emergency employment interventions.

The DOLE noted that the assistance has provided hope for recovery and a fresh start.

Last month, the DOLE mobilized the TUPAD program, providing PHP843 million worth of temporary wages to over 160,000 beneficiaries that were affected by two typhoons.

According to the Bureau of Workers with Special Concerns (BWSC), the Labor Department's response to Typhoon Tino has benefited 68,349 affected workers through emergency employment, amounting to over PHP363 million across Western Visayas, Central Visayas, Eastern Visayas and Caraga.

**Pork, carrot MSRP to take effect Dec. 5**

MANILA – The Department of Agriculture (DA) on Wednesday announced that the maximum suggested retail price (MSRP) for selected pork cuts will be enforced starting Friday.

The move comes as the DA prepares to impose a temporary import ban on live hogs and pork products from Spain, currently the country's second-largest source of pork, following reports of an African swine fever (ASF) outbreak.

In an ambush interview, Agriculture Secretary Francisco Tiu Laurel Jr. said the agency is finalizing the pricing measure to keep retail prices stable during the holiday season.

"Ang target ko is by Friday, mailabas iyong (My target is to release by Friday) MSRP for other products," he said.

In particular, Tiu Laurel said they are set to impose the MSRP of PHP370 per kg. for pork liempo (pork belly) and PHP350 per kg. for pigue (ham) and kasim (shoulder).

On the planned suspension of imports from Spain, Tiu Laurel said products processed on or after Nov. 11 will be prohibited unless certified ASF-free.

"I think this Christmas season, medyo reasonable ang price ng pork. Pero, siyempre, sa demand baka tumaas ng konti (there's somehow a reasonable price of pork. But, of course, the demand might slightly increase). But, more or less, it's affordable," he said.

He assured consumers that the ban would not affect local supply, noting that cold storage facilities remain well-stocked and market prices have been relatively steady.

DA monitoring as of Dec. 1 shows pork ham in Metro Manila selling at PHP270 to PHP390 per kg., while pork belly ranges from PHP320 to PHP470 per kg.

Aside from pork, the DA will also impose an MSRP of PHP120 per kg. for imported carrots starting Friday. (PNA)

## DMW job fair draws Filipinos seeking work in Finland

MANILA – Thousands of Filipino workers flocked to the one-day overseas job fair of the Department of Migrant Workers (DMW) in Mandaluyong City on Wednesday, with lines stretching outside SM Megamall, hoping to get hired and work in Finland.

At the mega job fair, DMW Undersecretary Felicitas Bay said that although only pre-registered applicants were allowed inside, a drop-off system was still provided for walk-ins, noting the long line of hopeful applicants.

"We have available 800 job orders or vacancies for the various sectors, manufacturing, production, and those in the factory setup," she said.

"It's only a one-day job fair. But there are recruitment agencies. I mentioned earlier, we have six participating recruitment agencies. Nineteen ang active recruitment agencies na nagpapadala sa Finland (Nineteen recruitment agencies are actively deploying to Finland). So, the job seekers can always check on the website of the participating agencies."

One of the participating companies, Bondata, is seeking to hire skilled Filipino workers for industrial technology roles in Finland.

Bondata Partnership Director Rebekka Kiljunen shared that their company has been operating in the Philippines for three years and has already hired hundreds of Filipinos.

"We're very excited to be here. At the moment, our biggest sector is industrial technology. So, we have positions for CNC machinists, we have positions for concrete workers and welders. Macaranas said.

Welder is a big need that we have at the moment," she said.

Kiljunen said that successful applicants would have an initial contract of one year, with potential renewal.

Leilani Macaranas of IPAMS, Bondata's partner recruitment agency, meanwhile, urged applicants to prepare concise resumes highlighting relevant experience, certifications, and machinery handled.

She also reminded applicants to secure essential documents, such as passports, National Bureau of Investigation clearances, and educational credentials.

"Sa experience po namin deploying sa Finland, mga three to four months po, basta medically fit, tapos po mai-issue ka ng visa.

And sa amin po, wala pong babayaran. As in, no placement fee, no processing fee, no salary deduction po kami (In our experience, deploying to Finland takes about three to four months, so long as you are medically fit, then you will be issued a visa. And for us, there is no fee. As in, no placement fee, no processing fee, no salary deduction)," he said.

Bay, meanwhile, warned job seekers against illegal recruit-

Meanwhile, among those who queued up before dawn was 35-year-old Melanie Estrella Paras from Pangasinan, who took the bus at 1 a.m. to attend the fair.

"Gusto ko talagang mag-abroad para matulungan yung family ko, lalo na may dalawang anak ako. Mahirap din kasi maghanap ng trabaho dito (I really want to go abroad to help my family, especially because I have two children. It's also difficult to find a job here)," she said.

Another applicant, Arnel Romero, admitted that he was a bit nervous as it was his first time applying for an overseas job, while expressing confidence, noting that he brought with him all the needed documents.

"Bukod sa pagtulong sa pamilya, kasi yun naman ang gusto nating lahat... gusto ko mag-apply kasi karamihan doon sa Finland nadadala yung pamilya (Besides helping the family, because that's what we all want... I want to apply because most people in Finland get to bring their families with them)," he said.

## WHO issues first guidelines on GLP-1 therapies for obesity

GENEVA – The World Health Organization (WHO) on Monday released its first guidelines on the use of Glucagon-Like Peptide-1 (GLP-1) therapies for treating obesity, responding to what it calls a growing global health crisis affecting more than 1 billion people.

Obesity was linked to 3.7 million deaths in 2024, and the WHO warned that without decisive action, the number of people living with the condition could double by 2030. The GLP-1s are medicines that help people feel fuller for longer.

"Obesity is a major global health challenge that WHO is committed to addressing... Our new guidance recognizes that obesity is a chronic disease that can be treated with comprehensive and lifelong care," WHO Director-General Tedros Adhanom Ghebreyesus said in a statement.

He added that while "medication alone won't solve this global health crisis, GLP-1 therapies can help millions overcome obesity and reduce its associ-

ers, stressing the importance of verifying whether an agency is licensed and has accredited job orders.

"Check if the agency is licensed, and even if the agency is licensed, meron ba siyang (do they have) job order registered with the DMW?" she said, noting that those eyeing overseas jobs must always check and verify through the DMW website. (PNA)



ated harms."

The guidelines said GLP-1 therapies may be used for the long-term treatment of obesity in adults, except pregnant women, though the WHO noted the advice is conditional due to limited long-term safety data, costs, and potential equity concerns.

The WHO also said intensive behavioral interventions, including structured healthy diet and physical activity programs, may be offered alongside the medications to enhance outcomes.

The agency emphasized that obesity is a complex, chronic disease driving cardiovascular illnesses, type 2 diabetes and some cancers, and contribut-

ing to worse outcomes from infectious diseases. The economic toll is projected to reach USD3 trillion annually by 2030.

The agency stressed the need for healthier environments, early interventions for high-risk groups, and life-long, person-centered care.

It also called for urgent action to ensure equitable access to GLP-1 therapies, warning that fewer than 10 percent of those who could benefit are expected to receive them by 2030.

In September, the WHO added GLP-1 therapies to its Essential Medicines List for managing type 2 diabetes in high-risk groups. (Anadolu)

## FEU-D sets up title duel with NUNS in UAAP boys' basketball

MANILA – Third seed Far Eastern University-Diliman defeated second seed University of Santo Tomas, 82-75, to reach the UAAP Season 88 boys' basketball finals on Wednesday at the Smart Araneta Coliseum.

Led by Dwyne Enriquez and Prince Cariño, the Baby Tamaraws recovered from a five-game slump to arrange a best-of-three title showdown with the National University Nazareth School (NUNS) starting on Dec. 6 at the Big Dome.

FEU-D lost to NUNS, 66-78, and 68-72, in the elimination round.

It will be the second championship duel between the Baby Tamaraws and the Bullpups since the inaugural tournament in Season 86, when Rob Celiz's buzzer-beating triple gave NUNS its first U16 crown.

"Of course, we're very happy that we recovered. We came back here and we beat them here in the knockout game. I always tell them that no matter how you fall, you have to learn to get back up — not just in basketball, but at home too. You can't just fall,

Enriquez delivered 22 points, seven rebounds, and four steals, while Cariño had 21 points, 22 rebounds, two blocks, and one assist for FEU-D, which prevailed over Adamson University, 90-76, in the stepladder quarterfinals on Nov. 30 to advance against UST in the semis.

Andrei Chavez chipped in 12 points,

seven rebounds, four assists, and two blocks, while Pineda added 11 points, 10 rebounds, five assists, and one steal.

Rowie Cabañero had 18 points, nine rebounds, eight assists, and two steals, while CJ Tabbuga contributed 14 points, 14 rebounds, five assists, and three steals as UST settled for third place after a runner-up finish in Season 87.

Gab Castro made 12 points, four rebounds, and one block, while Miguel Jubilado and Dave Regala had nine points each for the Tiger Cubs, who earned an outright semifinals ticket for ranking second in the elimination round with a 10-4 card. (PNA)

MANILA – De La Salle University pulled off an 87-77 victory over top-ranked National University on Wednesday at the Smart Araneta Coliseum to force a rubber match in the UAAP Season 88 men's basketball semifinal.

Jacob Cortez delivered 13 points, four assists, and two steals, while Mike Phillips had 12 points, 17 rebounds, and two blocks for the fourth-seeded Green Archers, who will try to secure a Finals berth with a victory in Game 2 on Saturday.

Kean Baclan has returned from an MCL injury, and EJ Gollena from suspension.

"We're extremely grateful and blessed to be here. Again, we just tried to prolong the series," said head coach Topex Robinson.

"Kean only got back in practice last week, so the guys decided to put in more work with this lineup. We're up against the No. 1 team, so it's always going to be a battle," he added.

Behind Mason Amos, JC Macalalag, and Cortez, the Green Archers extended their lead to 71-54 in the fourth quarter.

"Thank God Mason and Kean are back with us. Mason hit a couple of big shots, Kean played composed. We're still focused on the next game, which is do-or-die. We know NU's going to come out hard—it's up to us to focus on what we're going to do," said Cortez.

Gollena and Vhoris Marasigan chipped in 11 and 10 points, respectively. Macalalag and Pablo scored nine apiece, and Amos had eight points, including two triples in the

Meanwhile, defending champion NU nipped Ateneo, 67-66, to forge a title showdown with unbeaten University of Santo Tomas.

The Lady Bulldogs, ranked second in the stepladder playoffs with a 12-2 record, will be making their 11th straight championship appearance.

NU held a 9-1 run behind Ann Pingol, Tin Cayabyab, and Marga Villanueva to tie the count at 66-all, one minute remaining. Angel Surada split her charities off Nigerian center Sarah Makanjoula to seal the win.

"First of all, I want to thank the coaches and teammates for their effort. We dedicate this game to Coach DA. I'm proud of my teammates for their efforts because they didn't give up until the final buzzer," said Surada,

who had 15 points, eight rebounds, six steals, two assists, and one block.

NU's seven-year

reign ended when UST won Season 86, but the Lady Bulldogs managed to reclaim the title last season.

"Speechless. As I said, we weren't playing that well during this game, but the positive thing for this game is our players, everybody, did not quit. They didn't give up until the end even though things weren't going our way. I can't teach them that desire to win — they themselves, they didn't quit until the final buzzer," said NU head coach DA Olan.

Villanueva paced NU with 16 points, including four triples, alongside three rebounds, two steals, and one block.

Cayabyab had 15 points, two rebounds, two assists, and one steal, while Pingol added 10 points, six rebounds, five steals, and one assist.

Kacey dela Rosa delivered 18 points, 22 rebounds, six assists, and three steals, while Camille Malagar also had 18 points with six rebounds, two steals, and one assist as the Blue Eagles improved to third after three consecutive fourth-place finishes. (PNA)
